Greg, below is the Escambia County response to our request for the record of an Escambia County Board of County Commissioners Meeting held on October 23, 2017. EBOCC is contending that the meeting was properly closed to the public pursuant to Section 286.011(8), Florida Statutes (2017). This statute provides that EBOCC may meet in private with their attorney to discuss pending litigation provided: "The subject matter of the meeting shall be confined to settlement negotiations or strategy sessions related to litigation expenditures." We do not see how this meeting could possibly have been held for either of these reasons, because there were and are no "settlement negotiations" ongoing, and there do not appear to be any "litigation expenses" because the reply was handled by in-house counsel. We believe that this meeting dealt with the drafting of the EBOCC Response to the Sheriff's pending Budget Appeal, which is not a proper reason to close the meeting to the public.

We have requested a transcript of the closed portion of this meeting, and that request has been denied. See the email below. We believe that this response is also an improper denial of a request to produce a public record.

We also observe that the current EBOCC Chairman has publicly stated that it is his opinion that it's proper to conduct a "shade" meeting when the subject of the meeting is "potential litigation." We do not believe that this is permitted under Florida law.

On behalf of Sheriff Morgan, we respectfully request that you initiate an investigation into this meeting on the basis that it was wrongfully closed to the public in violation of Section 286.011(8), Florida Statutes (2017). We also request that you investigate the County's denial of our request for the transcript because the cited Statute does not permit denial of our request for a transcript of the meeting. We contend that EBOCC is wrongfully denying access to a public record in violation of Chapter 119, Florida Statutes (2017).
