### I. SUMMARY:

This bill allows stormwater management facilities in Pensacola to be exempt from Florida Law requiring certain properties in Escambia County to enclose, with a fence or other device of a height of at least four feet, any clay pits, caves or other depressions. The stormwater management facilities in the City of Pensacola are still subject to statewide applicable regulations regarding public safety or other more-restrictive ordinances.

#### B. PRESENT SITUATION:

Currently, chapter 57-1291, Laws of Florida, relating to Escambia County, provides that in the interest of public health, certain properties in Escambia County are required to enclose with a fence or other device of a height of at least four feet any clay pits, caves or other depressions that may cause a child to drown when filled with rain water.

Section 62-25.025 (6), Florida Administrative Code, rule of the Florida Department of Environmental Protection, states that unless local regulations are more restrictive, that in the interest of public safety, permanently wet retention and detention basins shall either be fenced or otherwise restricted from public access or contain side slopes that are no steeper than 4:1 (horizontal / vertical) out to a depth of two feet below the control elevation. All slopes shall be stabilized by either vegetation or other materials to minimize subsequent sedimentation of the basis.

## C. EFFECT OF PROPOSED CHANGES:

This bill amends a special act to exempt stormwater management facilities, located in the City of Pensacola, from this special act. Such facilities must be constructed in accordance with rules adopted pursuant to section 120.54, F.S., or other more-restrictive ordinances. The effect of the bill is that the stormwater management facilities in the City of Pensacola are still subject to statewide applicable regulations regarding public safety.

The unincorporated areas of Escambia County continue to be subject to the provisions of the special act.

#### D. SECTION-BY-SECTION ANALYSIS:

#### Section 1:

Section 1 of chapter 57-1291 is amended to allow stormwater management facilities in Pensacola to be exempt from Florida law requiring certain properties in Escambia County to enclose, with a fence or other device of a height of at least four feet, any clay pits, caves or other depressions which present drowning dangers to children. Such facilities must be constructed in accordance with rules adopted pursuant to section 120.54, F.S., or other restrictive ordinances.
