Re: Budget Issues

In an effort to explain the current budget situation of the Clerk of the Circuit Court and Comptroller's Office in Escambia County, Florida, I provide this letter to you in order to clarify and confirm the actions taken by this Office in the last months. Our Office is striving to manage our budgetary concerns without affecting the services provided to the Citizens of our County and your Offices. I regret that the severity of the situation is causing us to reduce our staff and possibly reduce the service options you currently experience.

As I have shared with you before, the budgets of our Office include: 1) Non-court services provided to the Board of County Commissioners and Citizens, such as Clerk to the Board functions and Finance; 2) Court-related services provided to the Judiciary, Attorneys, and Citizens, such as Civil, Criminal, and Probate functions and attending Court sessions; and, 3) Official Records services, such as recording documents dealing with property, as well as marriage license and passport services. Our Non-court services budget has been significantly supported by our Official Records budget in the past years. Our revenues have supplemented the operations of both budgets and as you know, such revenue has been reduced due to recent and current economic conditions. We anticipated that the implementation of Article V, Revision 7, in July of 2004 would have an impact on Court-related revenues. As a result of that implementation, our Court-related activities are supported by court fines and fees that we generate. There are several contributing factors for the significant decline in Court revenues; i.e., the decrease in civil filings and the decline in processed civil traffic infractions. Overall, while our Office has three budgets, we remain one organization with one purpose: to inspire public trust through integrity and excellence in customer service.

The number of employees in our Office, the number of departments, the number of vacant positions, the number of locations, and the numerous services we provide have been my focus these last months. Our ability to reach additional efficiencies and utilize technology to the ultimate purpose is being put to the absolute test. I join with you in knowing that the people of this County hired us to manage the offices they pay for, and failing to be

efficient in every way would be our greatest disservice to them. Therefore, we are in the process of reducing our staff and streamlining our organizational functions. I am aware that our reductions may affect the services you receive from our Office. Please know that we will take every possible measure available to keep both the quality and level of service consistent with your expectations. I thank you in advance for your patience and support.
