[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 7/09/09 a Home Invasion/Double Homicide occurred at 9717 Mobile Hwy, Escambia County, Florida. During the course of this investigation, it was determined that several suspects entered the victims' home armed with long guns and handguns. Leads were developed and numerous suspects were identified and interviewed by investigators. During the course of these interviews information was received concerning a red mini-van that was left at a predetermined location near the crime scene to facilitate their escape. The red mini-van was later determined to be registered to a white female identified as Pamela Long Wiggins.

Co-defendants reported that the firearms used during the course of this crime along with the victims' safe was later transferred into the red mini-van owned by S/Long-Wiggins and which was later observed at her business located at 4390 Gulf Breeze Pkwy, Gulf Breeze, Florida. It was reported that S/Long-Wiggins was the passenger in the red mini-van, which still contained the victims' safe along with the firearms used by the suspects, and that she had knowledge these weapons were used by the suspects during the commission of the Home Invasion/Double Homicide.

On 7/13/09 the Escambia County Sheriff's Office executed a search warrant at the residence of S/Long-Wiggins

located at 1247 Ramblewoods Rd, Gulf Breeze, Florida. During the course of this search, neither the victims' safe nor the firearms believed to be used in the home invasion were located.

On 7/15/09, Hugh Wiggins, during an interview with investigators, stated that the safe that was stolen during the robbery at 9717 Mobile Hwy was hidden in the back yard of the home owned by Pamela Long-Wiggins.
