Probable Cause Affidavit

Jane Schachle and Lawrence Tynes, being duly swom, hereby declare and state as follows:

Your Affiant, Jane Schachle, has been a Special Agent (SA) with the Florida Department of Law Enforcement (FDLE), for approximately 16 years, currently assigned to the Pensacola Regional Operations Center. Your Affiant, Lawrence Tynes, has been employed with the Santa Rosa County Sheriff's Office for 15 years.

This affidavit is the result of an investigation which began with your Affiant, SA Schachle, receiving information from the Santa Rosa County Sheriff's Office (SRCSO) regarding Lieutenant (Lt.) Mitch Tomlinson on March 3, 2010. This information consisted of allegations against Lt. Tomlinson that he had sexually abused , w/f, dob: hereafter referred to as the victim, from 9 to 18 years of age.

On Thursday, March 4, 2010, and Sunday, March 7, 2010, your Affiants interviewed the victim under oath regarding her father, Lt. John Mitchell "Mitch" Tomlinson, SRCSO. The victim verified that at the approximate age of 9, she because the victim's mother was sent to live with Mitch and ... died when she was six and her father did not want to raise the victim and her is the of the man the victim believed to be her and Mitch Tomlinson lived in their 3 bedroom home siblings. biological father. located on ... County. When the victim was almost 10 years old after moving in with the Tomlinson the victim reported when she would get out of the shower Mitch Tomlinson would tell her to sit in his lap and would insist on brushing her hair. The victim reported that she would wear a t-shirt and underwear to bed and would sleep on the top bunk in a bedroom she shared with Mitch Tomlinson's and the other children son who slept on the bottom bunk. After were asleep, Mitch Tomlinson would come into the victim's bedroom and try to get on the top bunk with her while standing on the bottom bunk where his son was sleeping. The victim reported that she acted like she was asleep and slept next to the wall to try and get away from him. The victim reported that since Tomlinson was a "big guy" he could not get to her and three to four days later that since the victim was a girl she Mitch Tomlinson told needed a bigger bed and moved the victim to the bottom bunk. After the victim was moved to the bottom bunk and after her younger brother fell asleep Tomlinson regularly entered her room and consistently rubbed on her legs, her chest and vaginal area. Tomlinson would try to wake her up, however, she would act like she was asleep. The victim explained that Tomlinson would rub her legs, breasts, vaginal area, back and buttocks with his fingers against her skin almost every day and it stayed like that for years until The victim reported that Tomlinson told her not to say anything about this as he could lose his job, no one would have a place to live and she would have to return to live with her father where she was abused.

The victim reported that when she was in approximately 9th grade and starting approximately 2002 or 2003, they moved to a house on in Santa Rosa County where Tomlinson performed oral sex on her. The victim reported that one day Tomlinson came home from work early when no one else was home and told her to go into his bedroom. Tomlinson pulled the victim's pants down, forced her to lie down on his bed because she was fighting him at the time and telling him to stop. Tomlinson told her she could not go to her friend's house. The victim asked him what he was doing to her because at that time she "did not know what any of it was". Tomlinson attempted to perform oral sex on her by forcing her legs apart. The victim resisted by kicking Tomlinson, who stopped his advances because

The victim reported another instance around the same time that Tomlinson came home early from work, no one was home and told her to go to his bedroom. Tomlinson told her to lie down on his bed and told her to take her clothes off. Tomlinson, who was clad in boxer shorts, put his hands on her knees, forced her legs apart and held her legs down. The victim stated that her arms were behind her back and Tomlinson was holding her legs down to the point that the force made her groin area hurt. The victim stated that Tomlinson penetrated her vaginal area with his tongue for approximately two minutes as she was resisting, rolling around to try and get away. The victim stated that she was able to get away because a called Tomlinson and said she was on her way home. After this the victim went into her bedroom and cried because she felt so gross. The victim knew that she was not supposed to say anything about this and understood and believed that if she told she would be kicked out of the house, have no where to go since her biological mother was dead, and be turned over to the state.

 or there would be repercussions. Tomlinson, pulled his pants down, left his shirt on, and penetrated her vagina with his penis. The victim reported that the sex act lasted about 5 minutes and she did not know if he ejaculated in her. The victim reported that Tomlinson did not "call off work" before this happened. The victim reported that this occurred 2-3 times a week for weeks afterward and it was either oral sex on her or him "raping me". The victim stated that after a few weeks it averaged 4-5 days a month until she moved out of the house at 18 years of age. The victim reported that Tomlinson would move her dresser in front of her bedroom door to keep anyone from entering. The victim reported that Tomlinson told her if she said anything about the abuse she would not be able to go to her friend's house, he would lose his job and no one would have a place to live, and no one would get any money. The victim reported that when Tomlinson would give her money he would tell her, "you owe me later".

On March 4, 2010, your affiants interviewed who reported that the victim told her in approximately 1998 or 1999 that Mitch Tomlinson had inappropriately touched her. reported that she confronted Mitch Tomlinson and he "vehemently denied it" stated that she was suspicious of the victim's relationship with Mitch Tomlinson as he spent more time with the victim than he did her. described the victim's relationship with Mitch Tomlinson as being closer than most relationships almost to an intimate level.

John Mitch Tomlinson (w/m, dob: 5/5/63), between on or about October 1, 2003, and on or about April 1, 2006, in Santa Rosa County, Florida, as a person in a position of familial or custodial authority to a person less than 18 years of age did knowingly commit sexual battery upon a person 12 years of age or older without that person's consent in violation of section 794.011(8)(b), Florida Statutes (120 cts).
