**[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]**

**On 4/28/10 at approximately 0915 hours Mark H Clabaugh did knowingly and intentionally commit the offense of Burglary (attempted) at 14 Star Lake Dr in Escambia County Florida. This incident occurred as follows:**

**On 4/29/10 I made contact with V/Sindel at the main Sheriff's Office. According to V/Sindel while she was at her residence at 14 Star Lake Dr on 4/28/10 she observed a white male attempt to enter her residence by pulling on the door knobs of her french doors on the back of the house. According to V/Sindel she went to the doors to see who it was and once the suspect realized she was in the house he attempted to leave the property. V/Sindel stated she confronted the suspect in her yard and asked him what he was doing and wanted to know why he was looking in her windows. At this time, the victim notice he had a camera in his hand. According to V/Sindel the suspect was very flustered and stated he thought the house was for sale. The victim stated there is no for sale sign at her residence. According to V/Sindel she again asked the suspect his name and he stated Chris, but would not provide a last name. The suspect continued to walk away and entered a white Chevy Suburban I266BQ. This tag was run by Deputy Powell #250 which came back to a Shelley Reynolds on Tanglewood Dr. The vehicle showed being insured to a Mark Clabaugh.**

**This officer completed a photo lineup showing six photographs to the victim. The victim immediately identified Mark Clabaugh as the suspect who had tried to enter her home. V/Sindel then circled, initial with the date and time identified S/Clabaugh and completed a sworn written statement. At this time a warrant affidavit will be sent for judicial review.**
