

[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 04/19/11, [redacted] reported to Det. Cutler and Officer Weaver that her 10 year old daughter [redacted] disclosed to her that her music teacher, Mr. Kenneth Campbell, put his hands under her shirt, and fondled her breast. [redacted] was interviewed twice by investigators, and disclosed in both interviews that Kenneth Campbell fondled her.

Detectives interviewed Kenneth Campbell and subsequently placed him under arrest and charged him with Lewd and Lascivious Behavior.

On 05/10/11 DCF removed [redacted] from her mother's care for safety reasons. During the removal [redacted] asked DCF Inv. Phillips if she could talk to me about the case. With [redacted] mother's permission I spoke with [redacted]. [redacted] admitted that she lied about the incident involving Campbell. [redacted] stated that Campbell never fondled her or sexually molested her. [redacted] also stated that she hated going to Spencer Bibbs School and she knew that she would get to go to NB Cook School if she said she got raped at Spencer Bibbs. [redacted] stated that she hated going to music class every Tuesday. I told [redacted] that she ruined Mr. Campbell's life with her lies, and her response was, "so he deserved to go to jail, because he looked at me crazy and made me feel uncomfortable". [redacted] showed no remorse for her actions. I allowed [redacted] to visit with her mother in the interview room and she confessed to her mother that she lied about the incident so that she could go to NB Cook School.
