[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 09/26/2011, at about 1500 hours in Escambia County, Florida, Timothy Andrew Jansky did knowingly and unlawfully commit the offense of Witness Tampering, in violation of Florida State Statute 914.22 (4a), to wit:

On 09/13/2011, a Battery was committed upon [REDACTED] by another member of the Escambia High School Football team. This incident was investigated by Deputies August Busche and Chris Echelle and a Warrant Affidavit was later submitted for judicial review.

On 09/19/2011, Escambia High School Head Football Coach Scott Anderson made contact with Deputy Echelle and asked if charges were being pursued against his player in reference to the above mentioned incident. Deputy Echelle advised Coach Anderson that it appeared the charges would be filed. Coach Anderson asked Deputy Echelle to inform the parents of [REDACTED] that if charges were filed it would mess up the team chemistry and that he (Anderson) would be unable to ensure the safety of [REDACTED]. Coach Anderson further asked Deputy Echelle to tell the parents of [REDACTED] that if no charges were filed he (Anderson) would be able to ensure the safety of their child then. Deputy Echelle informed Coach Anderson that he would not be informing the parents of this request and Deputy Echelle documented a report of this conversation and forwarded it to Escambia High School Principal Michael Sherrill, as well as his (Echelle) chain of command.

On 9/23/2011, Principal Sherrill reportedly informed Coach Anderson that his request of Deputy Echelle was not to happen again and that he was to stay out of the matter and allow law enforcement to do their job. Principle Sherrill in a recorded statement advised he felt Coach Anderson had clearly understood that he was not to further interfere with their investigation.

On 9/27/2011, a letter was received from [REDACTED] in which [REDACTED] detailed a conversation which had taken place the afternoon before on 9/26/2011. [REDACTED] reported he had been contacted at school by Coach Jansky and informed that if he pursued charges in the battery incident mentioned above, he would no longer be allowed to play football.

On 09/29/2011, Coach Jansky in a sworn recorded statement advised that he had indeed informed [REDACTED] that if he pursued charges against his teammate he would not be allowed to play football. Coach Jansky added that he had relayed this message to [REDACTED] at the repeated request of Coach Anderson who specifically told him to tell [REDACTED] he would not play football if he pressed charges in the matter.

REPORT NO: EC SO11ARR020029

In a recorded statement taken on 09/29/2011, Coach Anderson admitted to saying in coaches meetings that [redacted] would not play football if he pressed charges, but denied advising Coach Jansky to tell [redacted] this information. Coach Anderson did admit he had asked Coach Jansky to speak to [redacted] and even advised that he continued to request Jansky talk with [redacted] after being told by Principal Sherrill to drop the matter.

In a sworn recorded statement taken on 09/29/2011, Assistant Coach Jon Macon advised that he had heard Coach Anderson say that [redacted] would not play football if he pressed charges against his teammate. Coach Macon advised he had not heard Coach Anderson request Coach Jansky contact [redacted] or his family. This was the same information received from Assistant Coach Lee Burt, in a sworn recorded statement taken on 10/03/2011. Coach Burt denied having knowledge of Coach Anderson telling Jansky to talk with [redacted], but he had heard Coach Anderson on a number of occasion say that if [redacted] were to press charges he would not play football.

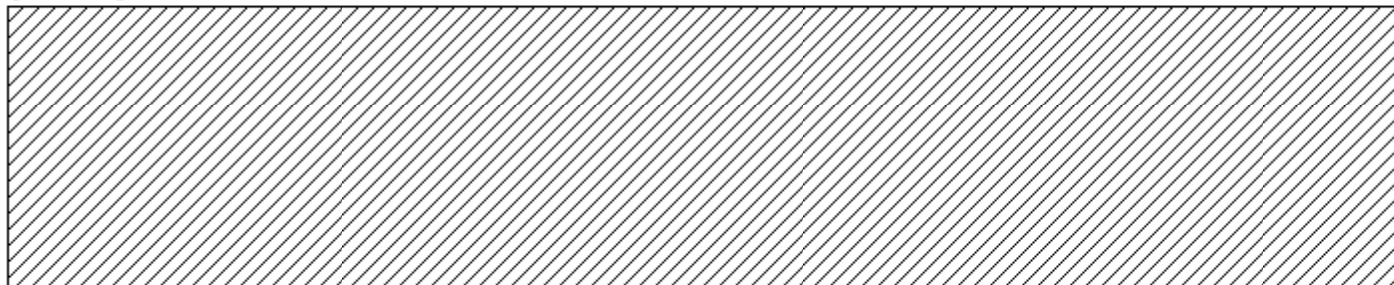

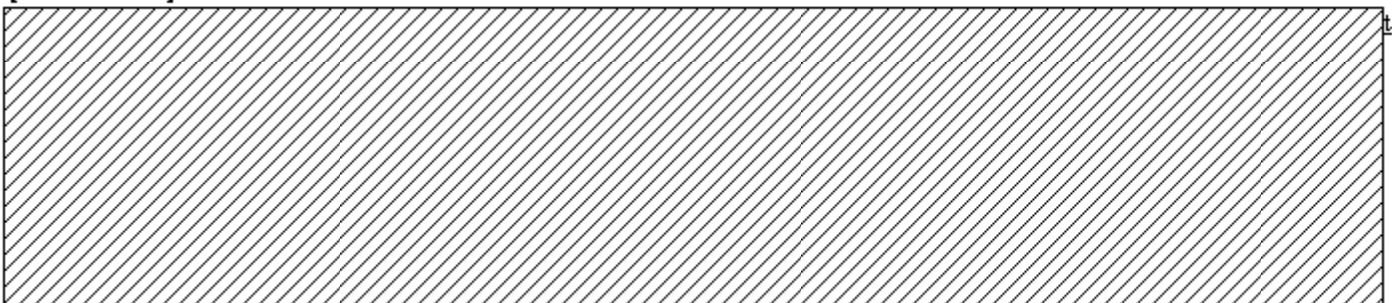

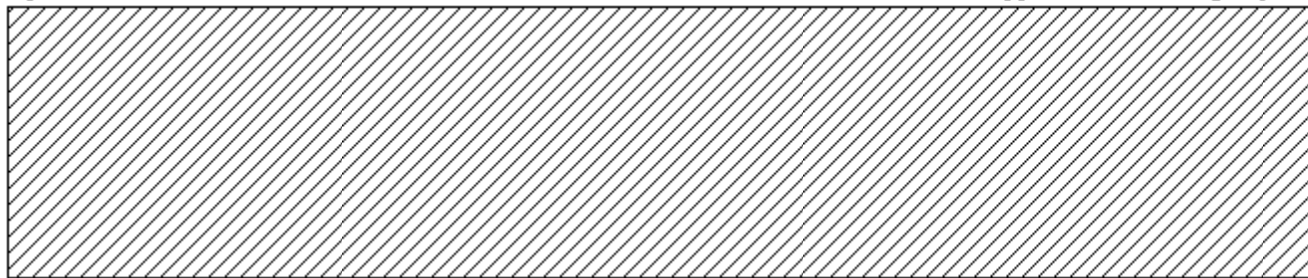
