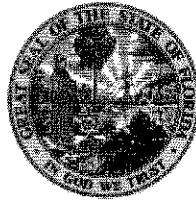

PRESS RELEASE

State Attorney William "Bill" Eddins announced today that it entered a Nolle Prosequi in the case brought against Vision Airlines, Inc. The State Attorney Office charged Vision with First Degree Grand Theft relating to their failure to remit more than \$100,000 in Passenger Facility Charges (PFCs) to the Northwest Florida Regional Airport.

Since the State filed the charge, Vision Airlines, Inc. paid restitution in the approximate amount of \$117,000. On March 11, 2013, Vision Airlines paid an additional \$43,477.94 in costs and legal fees owed to Okaloosa County and Northwest Florida Regional Airport. This amount includes \$13,783.64 payable to Okaloosa County as reimbursement for attorneys' fees as well as \$29,694.30 in interest and delinquent fees. Vision Airlines has agreed to cooperate with the Office of State Attorney and the Okaloosa County Sheriff's Office in their continuing investigation of the Tourist Development Council and related matters.
