Dear Commissioners:

Based on the Board's action last Thursday, it appears a new County Administrator will be in place as of February 28, 2014. I continue to believe that transfer of the Jail to the County is not in the best interest of the County or its constituent taxpayers. Transfer of the Jail by October 1, 2013 will be challenging and will come at a significant cost in terms of labor and funding. Once



the transfer is complete, reversing the process will be equally challenging. Additionally, transfer of the Jail will divert attention and resources from the many serious issues County government now faces.

I offer the following proposal to delay, the transfer of the Jail to the County. I am amenable to entering into an agreement to retain management of the Escambia County Jail until October 1, 2014. I envision that agreement to delay the transfer will include the following provisions:

- The County will agree to increase my Jail budget for FY 2014-2015 by \$2.6 million (in addition the mandatory FRS and health insurance increases (see attached chart for details) to allow for hiring of a portion of the increased staffing recommended by the Department of Justice;
- I will agree to defer seeking pay parity (the 2.6 million of my original submission for payment for holiday and overtime compensatory time) for Detention Deputies and Deputy Sheriffs until the FY 2014-2015 budget negotiations; and
- 3. I will agree not to appeal my FY 2013-2014 budget to the Governor, provided that the Law Enforcement and Court Security budgets are not reduced below the levels previously agreed upon by County staff (see attached chart).

Obviously, whether the increased staff adequately addresses the issues in the findings letter will be subject to approval by Department of Justice.

Please note that the budget figures referred to in this letter **DO NOT** include a 3% merit raise.

In my opinion, this suggested resolution will be much more palatable to the Department of Justice than the current plan to hurriedly transfer the Jail. Additionally, if it is ultimately necessary to transfer the Jail to the County, delay of the transfer will allow for a much more orderly transfer. It is also possible that we may be able to successfully negotiate the remaining issues, in the next budget year and transfer of the Jail may not ever be required.

In the interim, we must proceed with planning for the transfer because time is so short.

Please advise me in writing if you are amenable to pursuing such an agreement. If so, we can take steps to appoint an appropriate negotiating team.

I look forward to your prompt reply.
