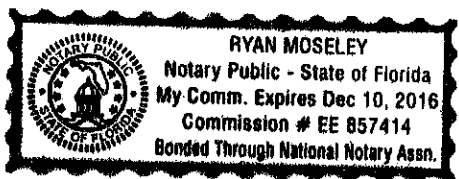


Exhibit A

Commence at the Northwest corner of Lot 11, Block 118 of the East King Tract for the point of beginning ("POB"), thence Southerly along the West line of Lot 11 for 150', thence Easterly at right angle along the South line of Lot 11 for 30', thence Southerly at right angle along the West line of Lot 29 for 150', thence Easterly at right angle for a distance of 30', thence Southerly at right angle (along an extension of the West line of Lot 28 for a distance of 50' to its intersection with the South right-of-way line of Hernandez Street Easterly to its intersection with the West line of the Louisville & Nashville Railroad right-of-way approximately 420' more or less, thence North along the West line of the Louisville & Nashville Railroad right-of-way to its intersection with the South right-of-way line of Jordan Street approximately 370' more or less, thence Westerly along the South right-of-way line of Jordan Street to the POB approximately 400', more or less, Less Lot 18 of Block 118, all in the East King Tract, according to the map of the City of Pensacola, Florida, copyrighted by Thomas C.
