The above referenced property receives an Economic Development Tax Exemption that was granted based on the fact it was located within an Enterprise Zone. The Florida Legislature allowed the statute supporting the "Enterprise Zone" to sunset December 31, 2015. This office recently asked for an opinion from the Attorney General regarding the renewal of such exemptions after December 31. The opinion is attached for your information. This office is concerned that this opinion may jeopardize the renewal of your exemption for 2016. We advise you to contact the granting authorities (City of Pensacola and/or Escambia County) to discuss this issue.
