[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 02/07/2017, at approximately 0900 hrs, I was acting in the capacity of the School Resource Officer at Washington High School. I was contacted by Administrative Dean George Schellang in reference to student possibly carrying a firearm onto the school's campus on Friday, February 3, 2017.

I made contact with Schellang in his office. He had another student in his office, [REDACTED] who advised that she had seen the weapon. Schellang asked [REDACTED] to tell him what happened. [REDACTED] advised that on Friday, February 3, 2017, [REDACTED] told her that he was going to shoot himself during lunch. [REDACTED] said that she and [REDACTED] have the same first period class. [REDACTED] said that during that class, [REDACTED] told her his plans and opened his backpack and showed her a gun. [REDACTED] described the gun as black and silver, but she didn't know what type it was. [REDACTED] said that one of [REDACTED] friends, William Caldwell, took the gun away from him. [REDACTED] said that she did not know what Caldwell did with the gun or where he put it.

Schellang and I went to Caldwell's second period class, to check on his welfare, and asked him if he would come to the Dean's Office. Caldwell followed and we went into Schellang's office. Schellang told Caldwell that some information had been received about another student bringing a gun onto campus and that he had possibly taken it away from him. Caldwell stated that he knew what Schellang was talking about and that he had taken the gun away from [REDACTED]. Schellang asked Caldwell where the gun was and he pointed to his backpack and indicated that it was inside. Schellang took the backpack from Caldwell and opened it. Inside of the backpack, on the bottom, we located a black and silver semi-automatic handgun. I retrieved the handgun from the backpack and found that there was a loaded magazine in the grip, but no rounds in the chamber.

Caldwell began to spontaneously state that [REDACTED] told him, at the beginning of school on February 3, 2017, that he had a gun with him and planned on killing himself before school started. Caldwell said that when he saw [REDACTED] during

sixth period, he took the gun's magazine away from him and then he took the gun away from him. Caldwell said that he took the gun home over the weekend, didn't bring it to school on Monday, February 6, 2017, but brought it back to school on February 7, 2017 in order to give it back to [REDACTED]

[REDACTED] as removed from his third period class by Ofc. R. McLean #132 and brought to the Dean's Office. Ofc. McLean said that he read [REDACTED] his Constitutional rights and asked him if would speak with him. Ofc. McLean said that [REDACTED] admitted to bringing the gun to school on February 3, 2017 and said that he intended on using it on himself. Ofc. McLean said that [REDACTED] stated that he only intended on using the gun on him and did not intend on using it on anyone else. [REDACTED] was placed under a Baker Act by Ofc McLean, who will complete a supplement to this offense report.

Caldwell was placed under arrest and transported to the Escambia County Jail Rapid Intake.


