PRESS RELEASE

State Attorney Bill Eddins announced today that drug charges against Santa Rosa Island Authority Director of Administration, Robbie Schrock, have been dismissed.

On April 5, 2017, law enforcement conducted a traffic stop on a vehicle in which Robbie Schrock was a passenger and her husband, Adam Schrock, was the driver. Officers with Gulf Breeze Police Department stopped the vehicle for suspicion of Driving under the Influence after receiving several citizen complaints about erratic driving. During the traffic stop, officers located tetrahydrocannabinol (marijuana extract) in a plastic container and an electronic cigarette on the passenger side floorboard. Both Adam and Robbie Schrock were arrested.

Adam Schrock provided a sworn affidavit admitting ownership of the marijuana extract and the electronic cigarette. He stated that both of those items were his personal possessions and that he tossed them aside when stopped by law enforcement. As a result, the charges against Robbie Schrock cannot be proved and therefore, were dismissed. A copy of the affidavit is attached.

The State is proceeding in the prosecution of Adam Schrock for the charges of Possession of Controlled Substance, Possession of Drug Paraphernalia and Driving under the Influence. His next Court date is scheduled for August 22, 2017 before the Honorable David Rimmer.
