On 9/19/2017, I responded to 501 Cherokee Trl (Sherwood Elementary School) in reference to a cardiac arrest.

Upon arrival, I was flagged down by an unknown school staff member and told to go to the school's clinic. I grabbed my agency issued AED and ran to the school's clinic. Upon arrival, I saw the school medical technician, later identified as OP/Kathy Sharpe, performing CPR by doing chest compressions on V/Audi Anderson (age 4).

I opened my AED and exposed V/Anderson's chest and back and applied both AED patches. I felt for a pulse on his right wrist and neck areas. V/Anderson did have a faint pulse and was experiencing agonal breathing. The AED analyzed V/Anderson and advised no shock, but to continue compressions. I took over applying chest compressions and checked for an airway obstruction. V/Anderson began to spit up what appeared to be blood.

Deputy Calogero #298 arrived on scene.

EMS responded and took over emergency medical attention for V/Anderson.

Sgt. Biggs #108 and Sgt. Johnson #069 arrived on scene and notified Command Staff, along with Investigations.

V/Anderson was transported to Baptist Hospital, then transported to Sacred Heart Hospital to continue emergency medical needs.

V/Anderson's mother was notified by school staff and responded to Sacred Heart Hospital.

OP/Sharpe completed and signed a sworn written statement.

It should be noted, this incident began in the school cafeteria during lunch. V/Anderson began to choke on the food that he was eating and was noticed by school staff to be in distress. V/Anderson was in breathing distress for an unknown length of time.

The following is supplemental information in reference to case #17-026944

On September 19, 2017, I was notified by dispatch of a crime scene request at 1000 W. Moreno St at Baptist Hospital in reference to a cardiac arrest. I arrived on scene at approximately 1104 hours. I made contact with V/ Audi Anderson (DOB: 1/7/2013) in trauma room #10. I observed a white male, clad in a diaper. The subject was unconscious, with a breathing tube attached to his person. I observed a bruise down the middle of his forehead. I observed no other visible injuries to the subject. I took digital photographs of the subject with and without a scale for identification a documentation purposes. While in the emergency room, I located the subject's shoes and socks, I was unable to locate his clothing which I was advised EMS crew had cut off the subject. I observed no other areas of concern; I departed the scene at approximately 1226 hours.

Upon my return to the Sheriff's Office, I downloaded the photos into the Crime Scene Database. All evidence collected was turned into the Evidence Unit.
