COMPLAINT

COMES NOW, the Plaintiff, GENE M. VALENTINO, by and through his undersigned counsel, and sues the Defendants, RAY GUILLORY (hereinafter "GUILLORY") and DOUGLAS UNDERHILL (hereinafter "UNDERHILL"), and for his cause of action alleges as follows:

1. This is an action for damages in excess of \$15,000.00.
2. The Plaintiff, GENE M. VALENTINO, is a natural person residing in Escambia County, Florida.
3. The Defendant, GUILLORY, is a natural person residing in Escambia County, Florida.
4. The Defendant, UNDERHILL, is a natural person residing in Escambia County, Florida.
5. The acts, events, and occurrences complained of herein occurred within Escambia County, Florida.

6. Prior to the publication of the defamatory material that is the subject of this lawsuit, the Plaintiff enjoyed a reputation for integrity and marital fidelity.

7. On or about June 24, 2017, on a Facebook social media website -- the largest social media organization in the world -- GUILLORY, on behalf of himself and UNDERHILL, published the materials that are attached hereto as Exhibit "A." In pertinent part, those materials accuse the Plaintiff of engaging in affairs and marital infidelities.

8. The publication of these statements were intended to cause aspersions upon the Plaintiff's conduct and character.

9. The statements made by the Defendants, GUILLORY and UNDERHILL, and the implications contained therein, are false, malicious (in law and fact), and defamatory.

10. The statements published by the Defendants were done so in complete disregard of their obviously harmful effect on the Plaintiff's reputation and good-standing in the community.

11. As a result of the publication of the various statements noted herein, the words and the implications which they carry have caused, and will continue to cause, the Plaintiff to be regarded with scorn, contempt, ridicule, and disrespect by the Plaintiff's contemporaries. These effects will continue into the foreseeable future.

12. As a result of the publication of the defamatory statements, the Plaintiff has suffered, and will continue to suffer, damage.

WHEREFORE, the Plaintiff prays that this Honorable Court will enter judgment in his favor and against the Defendants for damages, together with awarding the Plaintiff his taxable costs in this matter.

Demand for Jury Trial

Pursuant to Rule 1.430, Florida Rules of Civil Procedure, the Plaintiff demands a trial by jury on all issues so triable.

4. Records made or received in connection with official business

In evaluating whether a record is made or received in connection with the official business of an agency, "the determining factor is the nature of the record, not its physical location." Thus, the Florida Supreme Court found that personal e-mails between government employees on government-owned computers which were not made or received in the course of official business did not constitute public records.¹⁵

Similarly, the mere fact that an e-mail is sent from a private e-mail account using a personal computer is not the determining factor as to whether it is a public record; it is whether the e-mail was prepared in connection with official agency business and intended to perpetuate, communicate or formalize knowledge of some kind.

You need to make records request for any personal emails pertaining to county business. including but not limited to Party Down South, Madd dog productions, and Paul Sinor.
