[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 02/20/2018 at around 1400 hours, I was working in the capacity of School Resource Officer at Pensacola High School. I was summoned to the office by the Assistant Principal, Al Marsh. Marsh advised me that Dean Beth Howard had shown him a Facebook post that had been made by a former student named Trashawn Montrell Powers. Dean Howard then showed the post to me. In the post, Powers made the statement, "I'm Finna shoot up phs". Powers is a former PHS student that was removed for disciplinary reasons and sent to the Judy Andrews school. Several of Powers' Facebook friends warned him that he was going to get in trouble for making the post. Powers responded that he did not care.

As Powers' location was unknown, Pensacola High School was placed on lock down. This caused a major disruption of school functions as all movement in the halls was prohibited and teachers stopped teaching in order to secure their classrooms and students. I immediately notified Sgt. Patrick Bradley of the situation and received permission from him to send Escambia County Sheriff's Deputies to the Judy Andrews School in order to secure Powers. A short time later the ECSO notified me that Powers had been detained at Judy Andrews School.

Once Powers was detained, the lock down was lifted at Pensacola High School and normal school operations resumed. Powers was transported to the Pensacola Police Department for questioning. A screen shot of Powers' post was printed off and will be submitted with this report. Powers was arrested and charged with Disruption of School Function and False Report Concerning the Use of Firearms in a Violent Manner. Powers' mother, Andrea Griffin, was notified of this incident s well.

Powers was interviewed at the Pensacola Police Department by Detective Marcus Savage. Post Miranda, Powers admitted to making the threat and acknowledged that it was not a good idea. Powers stated that he had intended the remark as a joke. Powers was transported to DJJ.
