This report is for documentation purposes only.

On 2/25/2018 at approximately 2130 hours, I made contact with Kristen Reynolds and Brittany Lockaby at Pensacola International Airport in reference to a complaint of groping committed by their employer, Ryan Glitch. I separated Reynolds and Lockaby and interviewed them one at a time in the Conference Room at the airport, and they provided me with sworn verbal statements to the following.

On Friday, February 23, 2018, Lockaby and Reynolds worked at PensaCon (an event at the Pensacola Bay Center from 2/23/18 to 2/25/18) for Glitch's company, which was called Sci-Fi Speed Dating. Lockaby, Reynolds, Glitch, along with three other unidentified employees were staying at the Pensacola Grand Hotel (200 E Gregory) in room #601. After working all day at the convention on Friday, the group began to walk to Waffle House (401 E Gregory) at approximately 2000 hours. During this time while in the parking lot of the Grand Hotel, Glitch made a comment about Reynolds having "a nice ass." According to Reynolds, Glitch ran up behind Reynolds, reached out, and grabbed her right buttock with his right hand. Reynolds stated that at no point did she welcome such an advance or give permission for Glitch to touch her in such a way. Lockaby witnessed the entire incident and gave me a similar account.

Lockaby informed me that she has began working for Glitch's company for other conventions prior to PensaCon, such as Fan Expo in Toronto Canada. Lockaby stated that Glitch had

groped her in a similar manner at these conventions several years ago. Lockaby and Reynolds stated that they have worked for Glitch several times and witnessed him make many lewd comments towards other females, along with grope several of them. Lockaby said that she has never made a complaint due to receiving paid lodging, airfare, pay, and access to conventions. She felt that if she made a complaint, then Glitch would deprive her of these privileges as retaliation. Lockaby and Reynolds stated that on 2/25/2018, the final day of the convention, they had enough of Glitch's behavior, so they left the Pensacola Grand Hotel and went to the Pensacola International Airport where they made contact with me.

Reynolds was adamant about not pursuing charges against Glitch. The alleged incidents against Lockaby occurred several years ago in other jurisdictions. I generated this report for documentation purposes due to several complaints the PensaCon staff had received in the past about Glitch's behavior.

Ryan Glitch and his company, Sci-Fi Speed Dating are prolific throughout the comic, anime, and gaming conventions across North America. I was able to pull up Glitch's picture through a Google search of "Ryan Glitch Sci-Fi Speed Dating." Through such a search, Reynolds and Lockaby identified Glitch as the full-bearded, heavy-set white male who always wore Jedi-Knight robes at the conventions. There are numerous videos and news articles on
