Incident Situation:

- Local State of Emergency extended through July 20, 2020
- EOC liaisons are working from normal office locations M-F 8a-5p and supporting the EOC remotely as needed.
- EOC staff will be monitoring activities on weekends and holidays.
- As of 3:30 pm, 7/8/2020, the County has 3,188 positive COVID cases, 132 hospitalizations, and 51 deaths.
- County government services are open to the public with CDC guidance being recognized and implemented.
- Limited feeding services are being provided in the community weekdays.
- CSA mobilized on 3/22/2020. Staff are on call for very sporadic supply delivery.

		As of April 6, 2020, ECAT continues to operate a modified (reduced) service schedule, and implemented no fares and rear-boarding policies to comply with social-distancing recommendations.	

		ECAT continues social-distancing, encouraging use of facial masks, gloves and limiting ridership to more than 10 passengers per unit.	
		ECAT continues to operate a modified service schedule. Service to Pensacola Beach was resumed on May 4, 2020.	
		ECAT continues modified service, no-fares and rear boarding. Encouraging, use of face coverings and maintaining social distancing.	
ESF 1 Transportation:	Minor Issues	ECAT continues limiting ridership to no more than 10 persons per unit, rear-door entry, no fares and encouraging use of facial masks. 		ECAT ridership is increasing but staff is still encouraging rear-door boarding, social-distancing with no fare collection. Buses are disinfected during layovers and at the end of the shift. ECAT building and facilities are frequently disinfected throughout the day. ECAT Operators are required to wear face coverings while operating buses. One ECAT employee has tested positive for COVID-19 and is at home under quarantine.	
		ECAT notified the public that service will operate during peak hours (6am-10am and 2pm-6pm) effective June 22, 2020. The reduction in service hours is a result of several staff under quarantine.	
		On Tuesday June 30th, ECAT resumed a modified service schedule.

-Ascension Sacred Heart Hospital is continuing its drive-thru COVID testing site. Site is located at 5192 Bayou Blvd, Pensacola. Pre-screening by phone required before showing up at the location for testing.
 -The Ascension Sacred Heart Call Center screens Ascension Sacred Heart potential COVID-19 calls. They have MD's/NP's standing by to direct calls and advise patients of their results.
 -Baptist refers clients that meet criteria are directed to a clinic location for testing. Their clinic screens for other causes of symptoms prior to the COVID-19 Specimen Collection.
 -EMS and Fire following COVID-19 PPE protocols for 911 calls that are pre-screened and meet minimum criteria.
 -The Florida Department of Health's call center is available 24/7 for the public 866-779-6121 or email at COVID-19@flhealth.gov
 -Community Health of Northwest Florida continues to operate a drive thru/walk thru testing site at different locations in Escambia County. All of their clinics are also taking COVID-19 Specimens if the patient meets criteria. On-site mobile and drive-through testing varies weekly with no pre-screening required.
 -Baptist Hospital, Community Health of Northwest Florida, West Florida Hospital and Ascension Sacred Heart continue to submit daily specimen collection data to the ESF-8 Desk.
 -ESF-8 is continuing Mission Entries with incoming Resource Requisition Request Forms Monday through Friday. Resource Requisition Request Forms are only being processed as Missions for Escambia County Long Term Care Facilities and First Responders. EM Logistics is handling received resources at our County Drop Site (6575 North W Street) and the distribution to our Long Term Care Facilities and First Responders. Pick-up open on Mondays and Wednesdays.
 -Work is ongoing with all Escambia County Long Term Care (LTC) facility's contacts to ensure that social distancing and PPE requirements/recommendations are being followed. All LTC facilities are contacted by phone or email every Monday, Wednesday and Friday mornings by the FDOH-Escambia LTC Outreach Team.
 -FDOH-Escambia Epi/Nursing are visiting all LTC facilities to help educate and identify problems.
 -FDOH-Escambia continues operating a COVID-19 walk-in testing site for its 7th week 07/05-07/11/2020 at the back parking lot of 1300 West Gregory Street for Florida residents. Dates/Times open are subject to change due to inclement weather or shortage of supplies.
