Dear Alison:

As you know, the McDonald Fleming firm successfully defended Commissioner Underhill in a defamation lawsuit filed by Mr. Scott Miller in the Circuit Court for Escambia County (Case No. 2019 CA 931). Judge Pitre found Commissioner Underhill to have "absolute immunity" from suit for allegedly defamatory statements because the Commissioner made the statements in question as part of his duties as a County Commissioner. The judgment was affirmed on appeal. We have previously provided you with a copy of the First District's per curiam affirmance and the subsequent mandate.

Enclosed are the firm's invoices for amounts owed relating to the successful defense of the lawsuit both at the trial court level *and on appeal*. As you will see, the total amount paid by Commissioner Underhill to date is \$10,726.49 and the remaining amount owed is \$12,739.46 for a total of \$23,465.95. We note that the matter came before the Board in November of 2019, and it chose to delay its decision until Mr. Miller's appeal was resolved. For ease of reference, I am including a link to the County Attorney's report from November 2019 containing the back-up you previously provided
