While we understand that the Board did not initially view the Commissioner's actions as being a part of his official duties, the courts have held otherwise. Per the Board's May 15, 2014 policy on legal representation, Commissioner Underhill is entitled to have the fees incurred in his successful defense of the lawsuit paid. Accordingly, we ask that the Board consider the unpaid invoices for payment at its next available opportunity, along with reimbursement of Commissioner Underhill for amounts already paid.

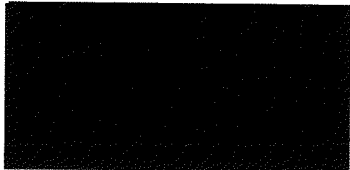
