

Mr. Collins asked to reschedule our planned call for tomorrow morning.

Below are the questions I just sent him for he and I to go over tomorrow. Once I have an understanding of his perspective, I will adjust the details that are found in the draft contract I have attached. As I mentioned previously, I am not sending him this draft until it is finalized and you and I have discussed it.

His starting salary in 2016 was \$91,000 without a moving stipend. Assuming an approximate 5% adjustment each year, his salary likely ended around \$126,000. I had one total phone call with Mr. Collins. We discussed the fact that he did not have a written contract the majority of time he worked for Fairview, I asked him the background on the termination benefits discussion that I noted from Fairview's records, and asked him if there was anything he wanted specifically addressed in the initial proposal. He said there was not, that he was extremely easygoing, and that he had been financially secure for a very long time, so his salary was not the most important aspect of his employment decision.

I told him about some of the terms in the current City Manager's contract, and said that if he did not deem any specific terms to be material, the terms would likely look the same. He said that should be fine.

I told him that I would go over the terms with Councilman Cusack, and should be able to send him an initial proposal by later that day or Friday.

The call lasted 23 minutes. It is the only call I ever had with Mr. Collins.

I am getting so much positive feedback from the public about Scott Collins coming tomorrow night and the council's consensus that he is the best choice. It is awesome that our town can get someone with his credentials and background. It will be such a clean slate and fresh start for us! I understand that there are some concerns about the salary negotiations and some figures are being thrown around that were not part of the original packet. Put it into perspective from a different field. If you were hiring a chef and you could get one that trained at PJC or you could hire one trained at Le Cordon Bleu, wouldn't you pay more for the qualified one? Bottom of the barrel gets \$120K. For no more than \$20K more, you get top shelf. There was a consensus that Scott Collins was top shelf. Anyway, PLEASE don't go along with them low balling Scott Collins on salary because they will just use that to place a much less qualified candidate. This could be merely a tool to try to manipulate outcomes and get your first choice to pull out. As a reference point, your current city manager's salary is \$144,227.20.
