Re: Establishment of Combined Workgroups on Vetoed Budget Issues

This term we have introduced to the House Rules the concept of a *combined workgroups*. The combined workgroups are designed to facilitate Member-to-Member conversations across jurisdictional silos over a fixed period of time with shortened notice requirements.

Chair Lawrence McClure in conjunction with Chairs Will Robinson, Josie Tomkow and Chuck Brannan have asked to create combined workgroups from budget and policy subcommittees to conduct a review of line-item vetoes from the 2024-25 General Appropriations Act (Chapter 2024 – 231, Laws of Florida). Per their request, I authorized the creation of the following four combined workgroups:

- Combined Workgroup on Vetoed Human Services Budget Issues composed of
 five members of the Health Care Budget Subcommittee chosen by Chair Alex
 Andrade and five members of the Human Services Subcommittee chosen by Chair
 Lauren Melo. I have appointed Representative Mike Redondo to serve as the
 Combined Workgroup Manager.
- Combined Workgroup on Vetoed Justice Services Budget Issues composed of
 five members of the Justice Budget Subcommittee chosen by Chair Patt Maney and
 five members of the Criminal Justice Subcommittee chosen by Chair Danny
 Alvarez. I have appointed Representative David Smith to serve as the
 Combined Workgroup Manager.

- Combined Workgroup on Vetoed Water Programs Budget Issues composed of
 five members of the Agriculture and Natural Resources Budget Subcommittee chosen
 by Chair Tiffany Esposito and five members of the Natural Resources and Disasters
 Subcommittee chosen by Chair Adam Botana. I have appointed Representative
 Michelle Salzman to serve as the Combined Workgroup Manager.
- Combined Workgroup on Vetoed Libraries, Cultural and Historical Preservation Budget Issues composed of five members of the *Transportation & Economic Development Budget Subcommittee* chosen by Chair Jason Shoaf and five members of the *Government Operations Subcommittee* chosen by Chair Linda Chaney. I have appointed Representative Susan Plasencia to serve as the Combined Workgroup Manager.

The workgroups will be authorized to meet beginning **Monday**, **February 10 for up to 10 days**. The authorized meeting schedule for combined workgroups will be very similar to the style we use for budget conference. General authorized meeting times will be available that any active workgroup may utilize. Workgroups are required to notice by 5:00pm the day before the workgroup meeting.

Upon conclusion of its work, each workgroup will submit its recommendation for further legislative action, if any, to their subcommittee chairs, the originating committee chair, and me.
