## **Re: Request for Public Records First Tee Gulf Coast**

Pursuant to First Tee’s Governmental Agency Funding Request Applications dated 9/29/25 and/or to Chapter 119, Florida Statutes (the Public Records Law), and Article I, Section 24 of the Florida Constitution I hereby request access to and copies of the following public records on behalf of the Escambia County Clerk of Court.

For the purposes of identifying a defined scope of time, unless otherwise specified, please consider the scope of time referenced in each request to be between January 1, 2024 and May 8, 2026.

For purposes of this request, the term “Communication” is defined very broadly to include, but not be limited to: Emails, text messages (SMS/MMS/iMessage), direct messages, instant messages, or any other electronic messaging; Letters, memoranda, notes, cards, or other written correspondence; Voicemail messages, audio recordings, or transcripts of phone calls; Video recordings, video calls, or video messages; Social media posts, comments, direct messages, or other interactions on platforms such as Facebook, X/Twitter, Instagram, LinkedIn, WhatsApp, Signal, or any other platform; Internal chat messages, Slack/Teams/enterprise messaging, or other collaboration tool communications; Meeting minutes, agendas, summaries, or notes that reference or memorialize any communication; Calendaring entries, scheduling records, or invitations that reflect communications or meetings; Any attachments, files, documents, photographs, spreadsheets, presentations, or data files transmitted or referenced in the above; Any other form of record that conveys information between the parties, including drafts and metadata.

### Records Requested:

1. All communications between the Greater Pensacola Junior Golf Association, Inc (“First Tee”), any of its officers, employees, board members, honorary board members, agents, designees and representatives and any employee, agent, designee or representative of the Escambia County Board of Commissioners. This request includes any communication between First Tee and any individual Commissioners of the Escambia County Board of Commissioners.

2. All internal communication within First Tee and its leadership and board members regarding funding requests from Escambia County.
3. A list of all attendees, sponsors, vendors and donors of the 2025 and 2026 Golf Ball Galas.
4. All Financial records regarding the 2025 and 2026 Golf Ball Galas.
5. All communication regarding scholarships awarded or anticipated in relation to the 2025 and 2026 Golf Ball Galas.
6. First Tee's 2025 and 2026 approved budget.
7. First Tee's 2025 and 2026 year-to-date profit and loss statements.
8. First Tee's 2025 and 2026 year-to-date income statements.
9. All contracts or agreements with the Escambia County Board of Commissioners or Escambia County.
10. All contract, billing information and cancelled checks between First Tee, its officers, employees, board members, honorary board members, agents, designees and representatives and Alexander Andrade, Esq. or Moore, Hill & Westmoreland, P.A. Attorneys at Law.
11. All records prepared prior to litigation or for other purposes by Alexander Andrade, Esq. or Moore, Hill & Westmoreland, P.A. Attorneys at Law.

This request includes all such records regardless of format or medium (electronic, paper, digital, cloud-based, backup, archived, or deleted-but-recoverable), and includes any records stored on personal devices, personal accounts, or third-party systems if used for official business.

Please produce the records in their native electronic format where possible, with all metadata intact. If any portion of a responsive record is withheld, please provide the basis for withholding.
