**DEFENDANT'S OFFER OF JUDGMENT FOR SETTLEMENT**  
**(served but not filed)**

The Clerk of the Circuit Court and Comptroller of Escambia County hereby makes an Offer of Judgment/Proposal for Settlement to Plaintiff Greater Pensacola Junior Golf Association, Inc.

**1. Amount of Offer**

- The total amount of this Offer is Fifty Dollars (\$50.00).

**2. Non-Admission**

- This offer is made to avoid the continued utilization of government resources in litigating this cause of action. It is not, and shall not be construed as, an admission of liability, fault, wrongdoing, or abuse of discretion by Defendant.

### **3. Acceptance Procedure and Deadline**

- This offer may be accepted by serving a written notice of acceptance on the counsel for the Clerk and filing the notice of acceptance with the Court within 30 days after service of this offer, but in any event no later than July 22, 2026.
- If acceptance is timely served and filed, any party may move for entry of judgment or for dismissal with prejudice consistent with the terms of this offer.

### **4. Payment Terms**

- Payment of the offered amount shall be made within 30 days after timely written acceptance and filing of a notice of acceptance, by delivering funds to Plaintiff's counsel.

### **5. Claims Resolved**

- Upon acceptance and payment as set forth herein, this offer resolves all claims, causes of action, damages, and remedies asserted or that could have been asserted in this action by Plaintiffs against Defendant, including claims for attorney's fees, interest, and costs.

### **6. Withdrawal**

- This offer is deemed withdrawn if not accepted as provided above within the acceptance period. Defendant may also withdraw this offer at any time before acceptance by serving a written notice of withdrawal on Plaintiff's counsel.

### **7. Enforcement**

- In the event of timely acceptance, the parties shall cooperate in filing any papers necessary to effectuate judgment or dismissal consistent with this offer. Any disputes concerning interpretation or implementation of this offer may be submitted to the Court for resolution.
